## ***Explore Aviation Camp Scholarship***

North Central Missouri EAA Chapter 944 is seeking candidates to send to the Explore Camp that is held each summer in Oshkosh WI. The academy consist of five days of exposure to aviation topics and is held at the site of Oshkosh fly-in, aviation's largest event. The Explore Camp will occur from July 25<sup>th</sup>, to August 2<sup>nd</sup> 2025

EAA Chapter 944 will pay all registration fees for each individual that is chosen by Chapter 944 members to attend. The registration fee includes all instructional materials, meals and lodging. The campers will stay in the beautiful EAA Air Academy Lodge located at EAA's AirVenture Museum in Oshkosh, Wisconsin.



Participants will share a bunkroom with three other campers and bathroom facilities centrally located on the same floor. High Standards of safety, appearance and cleanness are an EAA tradition and backed by American Camp Association accreditation.

Transportation to and from Oshkosh is the responsibility of the participant with free pick-up provided from the Appleton, Wisconsin airport for those wishing to go by commercial flight. All necessary Oshkosh area transportation is provided by EAA vehicles.

## ***Scholarship Application Process***

Eligible applicants: Boys or Girls, must be at least 16 but no more than 18 years old by the first day of camp. Each applicant must complete a written letter that answers the following questions:

- Why do you want to attend EAA's Explore Camp?
- What aviation experiences, education or training do you have to date?
- What aviation experiences would you like to gain from your EAA Explore Academy experiences?

***Your Application should be completed and must be submitted to EAA Chapter 944 By December 1<sup>st</sup>, 2024***

Selection of the winning candidates will be based on the evaluation of the application materials and appropriate follow-up by Chapter 944 members. The selection of the winner(s) will be made by December 31, 2024

- Allow Chapter 944 to submit your picture and story to the media.
- Help Chapter 944 during its annual Fly-in/Drive-in Pancake breakfast and Young Eagle's flights, held the 2nd Saturday in June.
